Conditions:

EU Citizenship

A registration fee of € 200 is to be paid when submitting your application. This amount will be deducted from the tuition fees. If you withdraw from the course before 15th August, this deposit will be refunded. The tuition fees should be paid monthly (September to June) using a SEPA direct debit mandate:

Non EU-Citizens:

In order to fulfil the visa requirements non-EU citizens are required to pay 100% of the tuition fees on registration.

The tuition fees for the 3rd and 4th semester 2024/25 have to be paid in advance by June 2024.

Cancellation:

If the registration is cancelled before the start of the college year all payments except for € 200 administration fee will be reimbursed. If the student does not appear at the beginning of the college year and/or the cancellation is made within the first four weeks of the study year, one monthly instalment will be retained.

Withdrawal throughout the college year:

If a student withdraws due to personal reasons or due to academic performance throughout the college year the total tuition fees for the course year are payable.

Costs include:

The tuition fees cover: Costs for copies of learning materials as well as the materials for the practical subjects, the transport costs for day excursions and the costs for the practical examination required before the diploma examination. Free WIFI in the whole school area, use of the career centre to find internship places and to organize foreign trips, as well as tutoring.

Please note that not consumed meals cannot be reimbursed due to the absence or any other reason.

Other Conditions:

All students must be healthy in order to pursue a career in hospitality and tourism. Special dietary requirements cannot be accommodated for during the practical trainings.

If students are not insured with their parents and/or do not have an Austrian health insurance, an Austrian insurance is required. Costs for this insurance are not included in the tuition fee. (approx. € 75.00/month)
